This matter is before the Court on Plaintiffs' June 18, 2019 Motion for Preliminary Injunction [Doc. #: 14]. Defendant City of Bedford, Ohio has agreed to a stipulation, which would grant Plaintiffs the preliminary injunction prayed for in Plaintiffs' Motion. The Parties stipulate as follows:

- 1. Defendant City of Bedford, Ohio has agreed to suspend enforcement of its Criminal Activity Nuisances Ordinance (Section 511.12 of the Bedford Codified Ordinances), and stipulates to continue its non-enforcement of the Criminal Activity Nuisances Ordinance during the pendency of this litigation. Defendant and all of its officers and agents, including the Bedford Police Department, agree to be enjoined from enforcing Section 511.12 of the Bedford Codified Ordinances until further notice. Non-enforcement under this stipulation requires Defendant to cease sending any nuisance letter to any person including but not limited to Plaintiffs, or taking any action to enforce any past nuisance letter or complaint under the Ordinance.
- 2. Defendant shall provide notice of this stipulation to the Police Department.

- 3. This stipulation will remain in full force until further action of the Court.
- 4. No bond is required.
