Nothing in Defendants' submission saves their implausible and unprecedented claims of authority. Defendants point only to traditional military facilities, including a military base built on the border between two states, and an off-site underwater training facility built specifically to serve Special Forces personnel stationed elsewhere. For the reasons stated in Plaintiffs' previous briefs, these discrete military facilities bear no resemblance to Defendants' proposed walls, which sprawl along a thousand miles of southern border, and are built for an immigration control mission that Congress explicitly assigned to a civilian agency.
