Enclosed please find a CD with the most recent set of data that is responsive to your recent public records request. The CD contains data related to the portions of your request articulated below. The process of gathering and redacting the remaining portion of your request continues. The disk has three files: MPD-TRACS-CitizenContact, MPD-TRACS-TSDC-Summary, and CodeTables. An explanation of how the data was categorized is as follows:

MPD-TRACS Citizen Contact:

File contains information collected using the citizen contact form within TRACS, from the data collection start date of December 1, 2010 through April 14, 2014. The one date listed prior to the data collection start date was collected as a sample process, used to test the efficacy of the system. This data is responsive to the following portions of your request:

4. All records, including, but not limited to, TRACS Citizen Contact database created since January 1, 2008:
 - a. The location or address of the stop, frisk, and/or search; **(A, B columns)**
 - b. The date of the stop, frisk, and/or search; **(C column)**
 - c. The duration of the stop, frisk, and/or search, or in the alternative, the time that the stop, frisk, and/or search was initiated and the time that it concluded; **Note: Field not captured/no responsive record.**

Code Tables


File contains the provide code tables, which convert the numbers from the various files into an English description.
